AltaGas Ltd. (the Operator) pursuant to Approval No. U2008-92 is the operator of a 7.2-MW power plant designated as the Parkland Gas Power Plant (the Power Plant) in the Stavely area.

The Operator, by Application No. 1579236 (the Application), registered July 14, 2008, applied to the Alberta Utilities Commission (the Commission) for a time extension on the completion date due to inclement weather delays.

The Commission, pursuant to section 11 of the *Hydro and Electric Energy Act* (the Act), being chapter H-16 of the Revised Statutes of Alberta, 2000, approves the Application and grants an approval to the Operator, to alter and operate the Power Plant, subject to the provisions of the Act, the Regulations, the Rules, Orders made pursuant thereto, and to the following terms and conditions:

- 1. The Power Plant shall be located in the LSD 6, Section 11, Township 15, Range 27, West of the 4th Meridian and as further described in the Application.
- 2. The Power Plant shall consist of three identical natural gas fueled, Cooper Superior Model 2516G-2000 engines rated at 2386 kW continuous duty. Each gas engine is used to drive a Baylor synchronous generator rated at 2400-kVA each at 1200 RPM. The total generation capacity of the Power Plant is 7.2-MW, as further described in the Application.
- 3. The Operator shall submit a progress report to the Commission in writing, once every three months on construction progress, pursuant to section 3 of the *Hydro and Electric Energy Regulation*. The first progress report shall be filed with the Commission, three months from the date of issuance of this approval.
- 4. Unless otherwise authorized by the Commission, construction of the Power Plant shall be completed by November 30, 2008.
- 5. The Operator shall notify the Commission within 30 days of completing the Power Plant.
- 6. The Operator shall obtain Commission approval prior to making any material changes to the Power Plant or substantially varying the design and/or specifications of the Power Plant from what was stated in the Application or what the Commission has approved.

- 7. This Approval is not transferable unless approved by the Commission.
- 8. The Commission may cancel, suspend, or amend this Approval, in whole or in part, upon its own motion, an application by an interested person, or failure of the Operator to comply with any provisions of the Act, the Regulations, the Rules, or this Approval.
- 9. Approval No. U2008-92 is rescinded.
