1 Introduction and background

- 1. On July 24, 2012, the Alberta Utilities Commission (AUC or Commission) issued costs award Decision 2012-197. Part 3, paragraph 11 of that decision contained an error regarding the legal experience of Mr. Clark of MacPherson Leslie & Tyerman LLP and awarded him \$320.00 rather than \$350.00 an hour being legal counsel with 12 or more years experience according to the AUC's *Scale of Costs*.
- 2. Further to Section 48 of AUC Rule 001: *Rules of Practice* this errata decision is issued to correct the error.
- 3. Paragraph 11 of Decision 2012-197 has been amended to correct the amount of fees awarded to Mr. Clark of MacPherson Leslie & Tyerman LLP. Attached to this errata decision is the amended and corrected costs award Decision 2012-197.

1 Introduction

- 1. On May 11, 2012, AltaGas Utilities Inc. (AUI) applied to the Alberta Utilities Commission (AUC or Commission) under Section 26(2)(a) of the *Gas Utilities Act*, RSA 2000, c. G-5, for approval and authorization to issue up to 201,543 Class A common shares at a price of \$34.7320 per share to AltaGas Utility Holdings Inc. for the maximum aggregate consideration of \$7,000,000.
- 2. The Commission issued a notice of application on May 15, 2012, advising interested parties to file a statement of intent to participate (SIP) to the Commission no later then May 29, 2012. No SIPs were filed.
- 3. On May 23, 2012, AUI submitted an officer's certificate, dated May 9, 2012, and a certificate of compliance from Industry Canada in further support of the application.
- 4. After reviewing the application, the Commission determined that no additional information was required to make a determination. On June 4, 2012, the Commission issued Decision 2012-152¹ approving the application.
- 5. On June 11, 2012, AUI submitted its costs claim, before the costs submission deadline of June 29, 2012.
- 6. On July 3, 2012, the Commission circulated a summary of costs being claimed by AUI to interested parties. Parties were advised that any comments regarding the figures listed in the summary or the merits of the costs being claimed were to be filed by July 17, 2012. The Commission did not receive any comments regarding the costs claimed in this proceeding. Accordingly, the Commission considers the costs process to have closed on July 17, 2012.

2 Views of the Commission – authority to award costs

- 7. When assessing costs claims pursuant to Section 21 of the *Alberta Utilities Commission Act*, the Commission applies the AUC Rule 022: *Rules on Intervener Costs in Utility Rate Proceedings* (Rule 022). Rule 022 prescribes a *Scale of Costs* applicable to the costs claimed.
- 8. In exercising its direction to award costs, the Commission must consider whether the participant acted responsibly and contributed to a better understanding of the issues before the Commission, and whether the costs claimed are reasonable and directly and necessarily related to

9. As the costs of a utility proceeding are generally passed on to customers, it is the Commission's duty to ensure that the customers receive fair value for a party's contribution. As such, the Commission only approves those costs that are reasonable and directly, and necessarily related to the party's participation in the proceeding.

3 Commission findings

- 10. AUI submitted a costs claim totalling \$2,671.62. The claim is comprised of MacPherson Leslie & Tyerman LLP legal fees in the amount of \$2,619.00, and disbursements in the amount of \$52.62.
- 11. The Commission has considered the costs claim submitted by AUI bearing in mind the principles specified in the Commission's *Scale of Costs*, as set out in Appendix A to Rule 022. The Commission finds that the hours incurred are reasonable for the tasks described in the costs claim. The Commission notes that the claim for professional fees and disbursements are in accordance with the *Scale of Costs*. Accordingly, the Commission considers AUI's claim for fees and disbursements reasonable and approves the total amount of \$2,671.62.

4 Order

- 12. It is hereby ordered that:
 - (1) AltaGas Utilities Inc. shall pay external costs in the amount of \$2,671.62, as set out in column (h) of Appendix A.
