AltaGas Holdings Inc., on behalf of AltaGas Pipeline Partnership, by Application No. 1608114 registered on February 1, 2012, filed an application with the Alberta Utilities Commission (AUC or the Commission) under Section 11 of the *Hydro and Electric Energy Act* to transfer the existing approvals and connection orders associated with the Coaldale, Burdett, Fort MacLeod and Taber power plants from Maxim Power Corp. to AltaGas Holdings Inc. The proposed ownership change is related to facilities previously approved in Approvals No. U2007-243,<sup>1</sup> No. U2007-247,<sup>2</sup> No. U2007-249<sup>3</sup> and No. U2007-251,<sup>4</sup> and Connection Orders No. U2007-244,<sup>5</sup> No. U2007-248,<sup>6</sup> No. U2007-250,<sup>7</sup> and No. U2007-252.<sup>8</sup>

In accordance with the requirements of Section 23 of the *Hydro and Electric Energy Act*, AltaGas Holdings Inc. is registered in Alberta pursuant to the *Business Corporations Act*. Based upon the information provided in the application, AltaGas Holdings Inc. has demonstrated that it is eligible to hold the power plant approval in its name. Furthermore, Maxim Power Corp. supports the application of AltaGas Holdings Inc.

The Commission approves the change in ownership for the power plants outlined in the application.
