1 INTRODUCTION

1. ATCO Gas and Pipelines Ltd. (South) (the Applicant) filed an application with the Alberta Utilities Commission (the Commission) seeking approval for an amendment/addition to Permit/Licence 1670 for the following:

- Splitting Line 14 into Lines 14, 21 and 22;
- Splitting Line 15 into Lines 15, 23 and 24;
- Splitting Line 16 into Lines 16 and 25;
- Splitting Line 18 into Lines 18 and 20;
- Removal of Lines 14, 15, 16, 20, 22 and 24;
- Mapping Correction of Line 14; and
- Addition of a newly constructed pipeline (Line 26 – 1.05 km of 219.1mm OD pipe)

(the Project).

2 BACKGROUND

2. The application was registered on March 12, 2010 as Application 1605984 (the Application).

3. The Applicant stated that the amendment/addition was necessary to facilitate the construction of the interchange at Anthony Henday Dr. and Stony Plain Rd.

3 DISCUSSION

4. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in *AUC Rule 020*. The Commission notes that a participant involvement program has been conducted by the Applicant and that there are no outstanding public or industry objections or concerns.

5. Since no parties objected to the Application and the Project is necessary to facilitate the construction of the interchange at Anthony Henday Dr. and Stony Plain Rd., the Commission considers the Project to be in the public interest.

4 DECISION

6. Pursuant to section 11 of the *Pipeline Act*, section 4.1 of the *Gas Utilities Act* and subject to the conditions stated in the Ministerial Consent file MCE10-0005 dated March 9, 2010, the Commission approves the amendment/addition to Permit/Licence 1670 for the Project and grants the Applicant the amended Permit/Licence as set out in Appendix 1 – Gas Utility Pipeline – Pipeline Splits, Removals, Mapping Correction and New Construction – Permit/Licence No. 1670 – March 18, 2010 (Appendix 1 will be distributed separately).
