Nevis Airdrie Transmission Pipeline in the Red Deer Area Licence 2029 Proceeding 22329 Application 22329-A001

Record amendment application

- 1. ATCO Gas and Pipelines Ltd. (South) (ATCO), by Application 22329-A001 registered on January 13, 2017, filed an application with the Alberta Utilities Commission under Section 12 of the *Pipeline Act* and Section 4.1 of the *Gas Utilities Act* for the following near the city of Red Deer:
 - length amendment of line 142 from 0.30 kilometres (km) to the revised length of 0.40 km
 - length amendment of line 198 from 2.67 km to the revised length of 2.57 km
 - length amendment of line 199 from 0.43 km to the revised length of 0.56 km
 - mapping amendments of lines 142, 198 and 199
- 2. The proposed amendment is related to facilities previously constructed and operated in accordance with approvals granted in Licence 2029.
- 3. ATCO stated that it received approval from the Commission in Decision 20560-D01-2015, to split line 142 into lines 142 and 198, remove line 142 and install line 199 to accommodate Lamont Land Inc.'s proposed residential development in the southwest quarter of Section 29, Township 37, Range 27, west of the Fourth Meridian.
- 4. ATCO stated that during construction, it became apparent that additional pipe would be required at the tie-in point to address a depth of cover issue, due to the proposed grading profile of the developer. As a result of the adjustment to the tie-in point, an additional length of pipe was removed. Therefore, amendments to the base map and length amendments to the records are required. ATCO has applied to amend the pipeline licence to accurately reflect the record of these pipelines.

Decision 20560-D01-2015: ATCO Gas and Pipelines Ltd. (South) – Nevis Airdrie Transmission Pipeline Relocation Project in the Red Deer Area, Minor Pipeline Project Application, Proceeding 20560, Application 20560-A001, July 7, 2015.

- 5. ATCO provided information respecting the need, nature and extent of the pipeline record amendments. Since the record amendments do not involve a ground disturbance, there will be no environmental impact.
- 6. Based upon the information provided, ATCO has demonstrated that the proposal is of a minor nature, no other person will be directly affected by the proposal and no adverse environmental impact will be caused by the proposed record amendment.
- 7. The Commission approves the application. The amended licence is attached.
