1 INTRODUCTION

1. ATCO Gas and Pipelines Ltd. (South) (Applicant) filed an application with the Alberta Utilities Commission (AUC or Commission) seeking approval for an amendment to Permit/Licence 3572 for the following:

- Re-Instate Portion of Line #2;

(Project).

2 BACKGROUND

2. The application was registered on July 22, 2010 as Application 1606383 (Application).

3. The Applicant stated that the amendment was necessary to reflect the most accurate information on the pipeline licence. The Applicant stated that in 2009 the line was approved for removal; however, during the removal operations, a segment of 1100m could not be removed due to the presence of a gravel berm that had accumulated over the pipeline since its installation. Therefore, the remaining 1100m of pipeline was abandoned, cleaned and capped in place as per AUC regulations.

3 DISCUSSION

4. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in *AUC Rule 020*.

5. Since the Project is necessary to reflect the most accurate information on the pipeline licence, the Commission considers the Project to be in the public interest.

4 DECISION

6. Pursuant to section 11 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the amendment to Permit/Licence 3572 for the Project and grants the Applicant the amended Permit/Licence as set out in Appendix 1 – Gas Utility Pipeline - Record Correction – Permit/Licence No. 3572 – July 29, 2010 (Appendix 1 will be distributed separately).
