1 INTRODUCTION

- 1. ATCO Gas and Pipelines Ltd. (South) (ATCO) filed an application with the Alberta Utilities Commission (AUC or Commission) seeking approval of an amendment to Permit/Licence 1950 for the following:
 - 'To' LSD Correction of Line No. 39;
 - 'From' LSD Correction of Line No. 118;
 - Mapping Correction of Line No. 39; and
 - Mapping Correction of Line No. 118;

(Project).

2 BACKGROUND

- 2. The application was registered on September 20, 2010, as Application 1606587 (Application).
- 3. ATCO stated that the amendment was necessary to reflect accurate information on the pipeline licence.

3 DISCUSSION

- 4. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in *AUC Rule 020*.
- 5. Since the Project is necessary to reflect accurate information on the pipeline licence, the Commission considers the Project to be in the public interest.

4 DECISION

6. Pursuant to section 11 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the amendment to Permit/Licence 1950 for the Project and grants ATCO the amended Permit/Licence as set out in Appendix 1 – Gas Utility Pipeline – Record Corrections – Permit/Licence No. 1950 – September 24, 2010 (Appendix 1 will be distributed separately).
