1 INTRODUCTION

1. ATCO Gas and Pipelines Ltd. (South) (ATCO) filed an application with the Alberta Utilities Commission (AUC or Commission) seeking approval for an amendment to Permit/Licence 15123 for the following:

- Length, Mapping and (Internal Protection) Code correction for Line 9;
- Add missing Environmental Code and Mapping correction for Line 11;
- Add line missing from Licence as Line 29;
- Split Line 16 into Lines 16, 34 and 35;
- Split Line 19 into Lines 19, 32 and 33;
- Split Line 25 into Lines 25, 30 and 31;
- Remove Lines 30, 32, and 34

(Proposed Amendment).

2 BACKGROUND

2. The application was registered on November 24, 2010, as Application 1606769 (Application).

3. ATCO stated that lines 30, 32, and 34 were removed at the time of construction due to the anticipated conflict (exposure of the pipelines) with the proposed highway construction. These removals were confirmed during a recent review of the 'As Built' drawings.

4. ATCO stated that the Proposed Amendment is necessary to reflect accurate information on the pipeline licence.

3 DISCUSSION

5. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in *AUC Rule 020*.

6. The Commission considers the Proposed Amendment to be in the public interest because it is necessary to reflect accurate information on the pipeline licence.

4 DECISION

7. Pursuant to section 11 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the amendment to Permit/Licence 15123 and grants ATCO the amended Permit/Licence as set out in Appendix 1 – Gas Utility Pipeline – Record Corrections – Permit/Licence No. 15123 – December 7, 2010 (Appendix 1 will be distributed separately).
