**AMENDMENT TO DELETE THE RECORD OF AN APPROVED
PIPELINE THAT WAS NOT BUILT**

1 INTRODUCTION

1. ATCO Gas and Pipelines Ltd. (South) (the Applicant) filed an application with the Alberta Utilities Commission (AUC or the Commission) seeking approval for an amendment to Permit/Licence 8488 for the following: (the Project)

- Deletion of Line 19.

2 BACKGROUND

2. The application was registered on September 11, 2009 as Application 1605449 (the Application).

3. The Applicant stated that the amendment was necessary to delete the record for Line 19 that was not built as approved in Permit/Licence 8488.

4. Line 19 was part of a re-alignment project to accommodate a City of Grande Prairie road widening project. Discussions between the Applicant and the City of Grande Prairie concluded that Line 19 was not required as part of the re-alignment.

3 DISCUSSION

5. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in AUC Rule 020. The Commission notes that a participant involvement program has been conducted by the Applicant and that there are no outstanding public or industry objections or concerns.

6. Since no parties objected to the Application and the Project is necessary to reflect a licenced pipeline that was not constructed, the Commission considers the Project to be in the public interest.

4 DECISION

7. Therefore, pursuant to section 11 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the amendment to Permit/Licence 8488 for the Project and grants the Applicant the amended Permit/Licence as set out in Appendix 1 – Pipeline Deletion – Permit/Licence No. 8488 – September 18, 2009 (Appendix 1 will be distributed separately).
