1 INTRODUCTION

- 1. ATCO Gas and Pipelines Ltd. (South) (the Applicant) filed an application with the Alberta Utilities Commission (the Commission) seeking approval for an amendment to Permit/Licence 6353 for the following: (the Project)
 - Splitting Line 1 into Lines 1, 2, 3, and 4
 - Removal of Lines 1 and 3

2 BACKGROUND

- 2. The application was registered on October 22, 2009, as Application 1605555 (the Application).
- 3. The Applicant stated that the amendment was necessary for the construction of the interchange at the intersection of Stoney Trail and Crowchild Trail located within the Calgary Transportation Utility Corridor (TUC).

3 DISCUSSION

- 4. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in AUC Rule 020. The Commission notes that a participant involvement program has been conducted by the Applicant and that there are no outstanding public or industry objections or concerns.
- 5. Since no parties objected to the Application and the Project is necessary for the construction of the interchange at the intersection of Stoney Trail and Crowchild Trail located within the Calgary TUC, the Commission considers the Project to be in the public interest.

4 DECISION

6. Therefore, Pursuant to section 11 of the *Pipeline Act*, section 4.1 of the *Gas Utilities Act*, and subject to the conditions stated in the amended ministerial consent file MCC04-0033 dated August 6, 2008, the Commission approves the amendment to Permit/Licence 6353 for the Project and grants the Applicant the amended Permit/Licence as set out in Appendix 1 – Gas Utility

Pipeline - Pipeline Split and Removal – Permit/Licence No. 6353 – October 27, 2009 (Appendix 1 will be distributed separately).
