ATCO GAS AND PIPELINES LTD. (SOUTH)
PIPELINE ADDITION FOR SERVICE TO A
PROPOSED REGULATING STATION

1 INTRODUCTION

- 1. ATCO Gas and Pipelines Ltd. (South) (the Applicant) filed an application with the Alberta Utilities Commission (the Commission) seeking approval for a new Permit/Licence 51878 for the following: (the Project)
 - Addition of a newly constructed pipeline (Line 1 30 m of 60.3 mm OD pipe).

2 BACKGROUND

- 2. The application was registered on November 10, 2009, as Application 1605614 (the Application).
- 3. The Applicant stated that the addition was necessary to provide service to a proposed ATCO Gas regulating station in 03-01-095-11 W4M.
- 4. The location and requirement of the proposed regulating station is determined by the local distribution company (LDC), which in this case is ATCO Gas.
- 5. The Applicant is responding to the LDC's request to provide a source of supply to their market. The public consultation for the pipeline followed the requirements of Rule 20. The need for the gate station was included in the information package.
- 6. The regulating station will be located in a rural location away from any concentrated population and is required to supply the local market. The LDC has obtained the necessary land rights to construct the regulating station at the proposed location and received no objection through their consultation process.

3 DISCUSSION

- 7. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in AUC Rule 020. The Commission notes that a participant involvement program has been conducted and understands that there are no outstanding public or industry objections or concerns.
- 8. Since no parties objected to the application and the Project is necessary to allow for service to a proposed regulating station, the Commission considers the Project to be in the public interest.

4 DECISION

9. Therefore, pursuant to section 9 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the new pipeline construction for the Project and grants the Applicant a new Permit/Licence as set out in the Appendix 1: Gas Utility Pipeline – New Construction – Permit/Licence No. 51878 – November 19, 2009 (Appendix 1 will be distributed separately).
