ATCO GAS AND PIPELINES LTD. (SOUTH) AMENDMENT/ADDITION TO REFLECT THE MOST ACCURATE INFORMATION ON THE PIPELINE LICENCE

1 INTRODUCTION

- 1. ATCO Gas and Pipelines Ltd. (South) (the Applicant) filed an application with the Alberta Utilities Commission (the Commission) seeking approval for an amendment/addition to Permit/Licence 1 for the following: (the Project)
 - Length correction of Lines 1 and 18.
 - Line split of Line 18 into Lines 18, 20, 21, 22 and 23.
 - Abandonment of Lines 1, 5, 20, and 22.
 - Deletion of Line 11.
 - Location correction of Line 12.
 - Removal of Line 14.
 - Mapping correction for Lines 12, 14 and 15.
 - Addition of existing pipeline (Line 24 150m of 114mm OD pipe) to existing licence.

2 BACKGROUND

- 2. The application was registered on November 17, 2009, as Application 1605625 (the Application).
- 3. The Applicant stated that the amendment/addition was necessary to reflect the most accurate information on the pipeline licence.

3 DISCUSSION

- 4. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in AUC Rule 020.
- 5. Since the Project is necessary to reflect the most accurate information on the pipeline licence, the Commission considers the Project to be in the public interest.

4 DECISION

6. Therefore, pursuant to section 11 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the amendment/addition to Permit/Licence 1 for the Project and grants the Applicant the amended Permit/Licence as set out in the Appendix 1 – Gas Utility Pipeline: Pipeline Split, Abandonment, Deletion, Removal, Record Corrections and Mapping

Corrections – Permit/Licence No. 1 – December 4, 2009 (Appendix 1 will be distributed separately).
