1 INTRODUCTION

- 1. ATCO Gas and Pipelines Ltd. (South) (the Applicant) filed an application with the Alberta Utilities Commission (the Commission) seeking approval for an amendment to Permit/Licence 7828 for the following:
 - Length, location and mapping corrections of Lines 17 and 24.
 - Location and mapping corrections of Line 19.
 - Mapping correction of Line 16.
 - Removal of Lines 17 and 19.

(the Project).

2 BACKGROUND

- 2. The application was registered on December 2, 2009, as Application 1605681 (the Application).
- 3. The Applicant stated that the amendment was necessary to reflect the most accurate information on the pipeline licence.

3 DISCUSSION

- 4. The Commission has reviewed the Application and has determined that it meets the requirements as stipulated in AUC Rule 020.
- 5. Since the Project is necessary to reflect the most accurate information on the pipeline licence, the Commission considers the Project to be in the public interest.

4 DECISION

6. Therefore, pursuant to section 11 of the *Pipeline Act* and section 4.1 of the *Gas Utilities Act*, the Commission approves the amendment to Permit/Licence 7828 for the Project and grants the Applicant the amended Permit/Licence as set out in the Appendix 1 – Gas Utility Pipeline: Record Corrections and Mapping Corrections – Permit/Licence No. 7828 – December 14, 2009 (Appendix 1 will be distributed separately).
