IN THE MATTER of an amendment to ATCO Gas and Pipelines Ltd.'s Rider "A" and Rider "C" with respect to the Village of Rosemary

### **ORDER U2003-440**

Application No. 1318336 File No. 6675-R11-1

ATCO Gas – North, a division of ATCO Gas and Pipelines Ltd. (ATCO Gas - North) applied to the Alberta Energy and Utilities Board (the EUB) for an Order approving an amendment to Rate Rider "A" (surcharge for a franchise fee). This allows the franchise fee in the Village of Rosemary (the Village) to be changed from 5.26 per cent of the gross revenue of ATCO Gas - North derived from the sale of natural gas within the Village to 14.78 per cent of the revenue of ATCO Gas -North from the delivery of natural gas within the Village, but excluding revenue derived from the cost of gas.

ATCO Gas – North has also applied for a change to Rate Rider "C" which recovers municipal taxes.

Notice of the application was published in conjunction with the Notice for the Village's application for renewal of its franchise agreement with ATCO Gas and Pipelines Ltd. and no objections were received. ATCO Gas - North has given the EUB consent to proceed with the application without a hearing.

The Board notes that these changes in rates result from the provisions included in the franchise agreement between the Village of Rosemary and ATCO Gas – North which was approved in Order U2003-439 issued in conjunction with this order. The franchise fee provisions included in the Agreement allow the Village to change the level of the franchise fee once annually within a cap of 35 per cent. Clause 4.c) of the Franchise Agreement includes a requirement for the Village to publish notice prior to any change in the level of the fee.

The Alberta Energy and Utilities Board, pursuant to the *Gas Utilities Act*, R.S.A. 2000, c. G-5, hereby orders as follows:

1. Application No. U2003-440 by ATCO Gas - North dated October 27, 2003, is approved, subject to the terms and conditions herein contained.

2. The new rate for the Village of Rosemary, as indicated on Rate Rider "A" attached as Schedule "A" to this Order, becomes effective upon the execution of the Village's Franchise Renewal Agreement with ATCO Gas and Pipelines Ltd.

3. The new rate for the Village of Rosemary, as indicated on Rate Rider "C" attached as Schedule "B" to this Order, becomes effective upon the execution of the Village's Franchise Renewal Agreement with ATCO Gas and Pipelines Ltd.

# ATCO GAS AND PIPELINES LTD. - SOUTH RIDER "C" TO RATE NO. 1 TO RATE NO. 8 AND ANY OTHER RIDERS THERETO

Additions to be made to the Rate of customers resident in municipalities that receive a property tax assessed under the Municipal Government Act. The addition is the estimated percentage of gross revenue excluding gas costs (Rider "F"), deemed value (Rider "E"), company owned production rate rider (COPRR) (Rider "G") and company owned storage rate rider (COSRR) Market Value portion of (Rider "H") required to provide for the tax payable each year. To the extent that this percentage may be more or less than that required to pay the tax, the percentage of gross revenue provided in the Rider will be adjusted on the 1st of February each year.

### AND

Additions to be made to the Rate of customers resident in areas or municipalities for the recovery of specific costs which are not generally incurred by the Company. The addition is the estimated percentage of gross revenue excluding gas costs (Rider "F"), deemed value (Rider "E"), company owned production rate rider (COPRR) (Rider "G") and company owned storage rate rider (COSRR) Market Value portion of (Rider "H") required to provide for the costs payable each year. To the extent that this percentage may be more or less than that required to recover the costs incurred, the percentage of gross revenue provided in the Rider will be adjusted on the 1st of February each year.
