**Bantry Power Plant and Connection Order Ownership Transfer  
Proceeding 23938  
Application 23938-A001**

**Power plant ownership change**

1. AltaGas Ltd., by Application 23938-A001, registered on September 28, 2018, filed an application with the Alberta Utilities Commission under Section 11 of the *Hydro and Electric Energy Act* to transfer ownership of the Bantry Power Plant and associated connection order to 2133151 Alberta Ltd. The proposed ownership change relates to facilities previously approved in Approval U2007-307<sup>1</sup> and Connection Order U2008-18.<sup>2</sup>
2. 2133151 Alberta Ltd. is the general partner of AltaGas Southern Processing Limited Partnership and will operate the power plant following the sale. The same personnel who have operated the Bantry Power Plant will remain in their roles and continue to operate the power plant.
3. In accordance with the requirements of Section 23 of the *Hydro and Electric Energy Act*, 2133151 Alberta Ltd. is registered under the *Business Corporations Act*.
4. AltaGas Ltd. stated that the sale of the Bantry Power Plant is conditional on the Commission's approval of the transfer of the approvals from AltaGas Ltd. to 2133151 Alberta Ltd. The transfer of the Bantry Power Plant is expected to occur on or before November 1, 2018. AltaGas Ltd. stated that in the event the transfer date is advanced or delayed, it will advise the Commission such that the appropriate date is reflected in any issued approvals.
5. Based upon the information provided, 2133151 Alberta Ltd. has demonstrated that it is eligible to hold the power plant approval and connection order in its name.

6. The Commission considers the transfer to be in the public interest in accordance with Section 17 of the *Alberta Utilities Commission Act*.

7. Pursuant to sections 11 and 18 of the *Hydro and Electric Energy Act*, the Commission approves the transfer of the power plant approval and connection order to 2133151 Alberta Ltd. The Commission will issue a new approval and connection order upon receipt of written confirmation from AltaGas Ltd. that the sale has been completed. Accordingly, the Commission directs AltaGas Ltd. to provide such confirmation no more than seven days after the transaction is completed.
