The Commission amended Licence 1974 under Section 12 of the *Pipeline Act*, and Section 4.1 of the *Gas Utilities Act* in Decision 24088-D01-2018¹ subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*.
