**Record amendment**

1. ATCO Gas and Pipelines Ltd. (ATCO), by Application 24209-A001 registered on January 4, 2019 filed an application with the Alberta Utilities Commission under Section 12 of the *Pipeline Act* and Section 4.1 of the *Gas Utilities Act* for the following in the County of Vermilion River:

- length amendment of line 1 from 3.66 kilometres to the revised length of 4.45 kilometres
- length amendment of line 18 from 0.02 kilometres to the revised length of 0.06 kilometres
- length amendment of line 19 from 2.97 kilometres to the revised length of 2.14 kilometres
- ‘To Location’ legal subdivision amendment of line 1
- ‘To Location and From Location’ legal subdivision amendment of line 18
- ‘From Location’ legal subdivision amendment of line 19
- mapping amendment of lines 1, 18 and 19

2. The proposed amendments are related to facilities previously constructed in accordance with approvals granted in Licence 2742.

3. ATCO stated that it received approval by Decision 23879-D01-2018<sup>1</sup> on September 20, 2018, to remove 20 metres of the abandoned 114.3-millimetre Wildmere Transmission Pipeline, line 18, to accommodate a future development, as requested by Gear Energy. However, ATCO removed 60 metres of the abandoned pipeline. The length removed was longer than expected and the location of the removal in Decision 23879-D01-2018 requires correction. Therefore, ATCO has applied to amend the pipeline licence and base map to accurately reflect the record of lines 1, 18 and 19.

4. ATCO provided information respecting the need, nature and extent of the pipeline record amendments. Since the record amendments do not involve a ground disturbance, there will be no environmental impact.
5. Based upon the information provided, ATCO has demonstrated that the proposal is of a minor nature, no other person will be directly affected by the proposal and no adverse environmental impact will be caused by the proposed record amendments.
6. The Commission approves the application. The amended licence is attached.
