IN THE MATTER of an amendment to ATCO Gas and Pipelines Ltd.'s Rider "A" with respect to the Town of Vulcan

#### ORDER U2000-243

Application No. 2000197 File No. 6675-V6-1

ATCO Gas and Pipelines Ltd. (ATCO Gas) applied to the Alberta Energy and Utilities Board (EUB) for an Order approving an amendment to Rate Rider "A" (surcharge for a franchise fee). ATCO Gas' franchise agreement with the Town of Vulcan (the Town) as approved in Order U2000-242 dated July 13, 2000 allows for an increased franchise fee from 5.26% to 7% which would be applied to transportation customers as well as sales customers. The franchise fee for transportation customers will be calculated on the transportation service revenue and the deemed value of the transported gas. The Town accepts this payment in lieu of taxing the special franchise, lands, buildings, improvements, pipelines, work and transmission lines, equipment and apparatus belonging to and used by ATCO Gas exclusively for the purpose of supplying natural gas within the Town.

Notice of the application was published in conjunction with the Notice for the Town's application for renewal of its franchise agreement with ATCO Gas. Notice was also served on transportation customers in the Town. No objections were received and ATCO Gas has given the EUB consent to proceed with the application without a hearing.

The Alberta Energy and Utilities Board, pursuant to the Gas Utilities Act, R.S.A. 1980, c. G-4, hereby orders as follows:

- 1. Application No. 2000197 by ATCO Gas and Pipelines Ltd. dated June 14, 2000 is approved, subject to the terms and conditions herein contained.
- 2. The new Rate Rider "A" for the Town of Vulcan, attached as Schedule "A" to this Order, becomes effective upon the execution of its Franchise Renewal Agreement with ATCO Gas and Pipelines Ltd.
