IN THE MATTER of an amendment to ATCO Gas and Pipelines Ltd.'s Rider "A" with respect to the Town of Taber

ORDER U2000-247

Application No. 2000217 File No. 6675-T1-1

ATCO Gas and Pipelines Ltd. (ATCO Gas) applied to the Alberta Energy and Utilities Board (EUB) for an Order approving an amendment to Rate Rider "A" (surcharge for a franchise fee). ATCO Gas' franchise agreement with the Town of Taber (the Town) as approved in Order U2000-246 dated August 1, 2000 allows for the franchise fee to remain at 5.26% for transportation and sales customers. The franchise fee for transportation customers is calculated on the transportation scrvice revenue and the deemed value of the transported gas. However, the franchise fee would not be applicable for revenues over \$1,426,000 for any one point of delivery. The Town accepts this payment in lieu of taxing the special franchise, lands, buildings, improvements, pipelines, work and transmission lines, equipment and apparatus belonging to and used by ATCO Gas exclusively for the purpose of supplying natural gas within the Town.

Notice of the application was published in conjunction with the Notice for the Town's application for renewal of its franchise agreement with ATCO Gas. No objections were received and ATCO Gas has given the EUB consent to proceed with the application without a hearing.

The Alberta Energy and Utilities Board, pursuant to the *Gas Utilities Act*, R.S.A. 1980, c. G-4, hereby orders as follows:

- Application No. 2000217 by ATCO Gas and Pipelines Ltd. dated June 29, 2000 is approved, subject to the terms and conditions herein contained.
- 2. The new Rate Rider "A" for the Town of Taber, attached as Schedule "A" to this Order, becomes effective upon the execution of its Franchise Renewal Agreement with ATCO Gas and Pipelines Ltd.
