Atco Gas Ltd. applied to the Alberta Energy and Utilities Board for an Order approving an amendment to Rate Rider "A" (surcharge for a franchise fee). This allows the franchise fee in the Village of Clyde to be increased from 5.26 per cent of the sale service revenue to 9.47 per cent of the revenue derived from the delivery of natural gas with the Village, exclusive of revenue derived from the cost of gas.

Notice of the application was published in conjunction with the Notice for the Villages application for renewal of its franchise agreement with Atco and no objections were received. Atco has consented to proceed without a hearing.

The Alberta Energy and Utilities Board, pursuant to the *Municipal Government Act*, S.A. 1994, c. M-26-1, hereby orders as follows:

- 1. Application No. 990220 by Atco Gas Ltd., dated 5 May 1999 is approved, subject to the terms and conditions herein contained.
- 2. The new rate for the Village of Clyde, as indicated on Rate Rider "A" attached as Schedule "A" to this Order, becomes effective upon the execution of its Franchise renewal Agreement with Atco Gas Ltd..

The percentage shown is to be applied as an addition to the billings calculated under the Rates including charges as allowed under other Riders in effect.

Method

- Applied to gross revenues excluding gas costs (Rider "F") and deemed value (Rider "E"). Applied to gross revenues including gas costs (Rider "F") from sales service rates.
- Applied to gross revenues including gas costs (Rider "F") and deemed value (Rider "E"). C.
- includes a \$370,000 maximum annual allowable assessment (Max) on any individual metered account.
- The deemed value of natural gas is applied only to customers using less than 300,000 G/s per year.
