## **Record amendment application**

ATCO Gas and Pipelines Ltd. (South) (ATCO), by Application No. 1611043 registered on December 2, 2014, filed an application with the Alberta Utilities Commission (AUC or the Commission) under Section 12 of the *Pipeline Act* and Section 4.1 of the *Gas Utilities Act* for the following in Township 37, Range 27, west of the Fourth Meridian:

- status amendment of Line 192 from 'operating' to 'removed'
- mapping amendment of lines 190 and 194
- length amendment of lines 190 and 192
- pipe grade amendment of Line 194 from 359 Category 2 to 359 Category 1

The proposed amendment is related to facilities previously constructed and operating in accordance with approvals granted in Licence No. 2029.

ATCO stated that this application is in relation to the Piper Creek exposed pipeline replacement project recently approved under <u>DA2014-189</u><sup>1</sup> and completed on September 25, 2014.

ATCO stated that the original intent for Line 194 was to install a pipeline having material specification of Grade 359 Category 2. However, Grade 359 Category 1 pipe meeting all CSA Z662 design requirements was substituted.

The mapping and length amendments are required to reflect the results of an as-built survey.

Line 192 was removed during construction and an application to reflect the abandonment of Line 190 will be submitted subsequently.

DA2014-189: ATCO Gas and Pipelines Ltd. (South) – Piper Creek Exposed Pipeline Replacement, Licence No. 2029, Minor pipeline project application, Application No. 1610731, Proceeding No. 3336, August 7, 2014.

ATCO provided information respecting the need, nature and extent of the pipeline record amendment. Since the record amendment does not involve a ground disturbance, there will be no environmental impact.

Based upon the information provided, ATCO has demonstrated that the proposal is of a minor nature, no other person will be directly affected by the proposal and no adverse environmental impact will be caused by the proposed record amendment.

The Commission approves the application. The amended licence is attached.
