**O R D E R**

**WHEREAS:**

- A. By Order E-3-12 dated February 23, 2012, the British Columbia Utilities Commission (Commission) approved the Annual Contracting Plan (ACP) submitted by Corix Multi-Utility Services Inc. (Corix) for propane supply for Panorama Mountain Village (Panorama) for the period from April 1, 2012 to March 31, 2013;
- B. On March 29, 2012, Corix filed an executed propane supply agreement for Panorama between Cal-Gas Inc. and Corix for the period from April 1, 2012 to March 31, 2013 (the Supply Agreement);
- C. By Order E-12-12 dated April 13, 2012, the Commission accepted for filing the Supply Agreement and ordered that the documents associated with the filing be kept confidential;
- D. On June 25, 2012, Corix filed an executed copy of an addendum to the Supply Agreement providing for a fixed price commitment for a portion of the propane supply commencing July 1, 2012 (the Fixed Price Commitment);
- E. Corix requests that the Fixed Price Commitment and related information be held confidential due to the commercial sensitivity of the information;
- F. The Commission has reviewed the submissions by Corix, and has determined that the filed Fixed Price Commitment is consistent with the ACP and in the public interest.
