**O R D E R**

**WHEREAS:**

- A. On September 8, 2008 Energy Savings (B.C.) Limited Partnership, carrying on business as Energy Savings B.C. ("Energy Savings B.C.") applied to the British Columbia Utilities Commission ("Commission") for a Gas Marketer Licence. The Application for Licence to Market Natural Gas included the payment of \$1,000 Application fee and a \$250,000 Letter of Credit, pursuant to items 2 and 3 respectively, of the Licence Requirements; and
- B. On October 10, 2008, relying upon the information and representations made by Energy Savings B.C. the Commission approved Gas Marketer Licence A-17-08 ("Licence") subject to conditions; and
- C. On June 24, 2009, Energy Savings B.C. notified the Commission that its name will change to Just Energy (B.C.) Limited Partnership on July 23, 2009 and requested an amendment to its Licence to reflect the new name; and
- D. The Commission has reviewed the application and is satisfied that an amendment to the Licence subject to conditions is warranted; and

**NOW THEREFORE** pursuant to Section 71.1(6) of the *Utilities Commission Act* the Commission orders as follows:

1. Licence issued to Energy Savings (B.C.) Limited Partnership, carrying on business as Energy Savings B.C., for the period of November 1, 2008 to October 31, 2009 is to be amended to recognize and reflect the change of name to Just Energy (B.C.) Limited Partnership, carrying on business as Just Energy.
2. The amended Licence will contain the same conditions and will be subject to an additional condition:
  - Just Energy will provide an amended Letter of Credit reflecting the new name of the Limited Partnership to the Commission on or before July 29, 2009.
