### **ORDER**

#### **WHEREAS:**

- A. On August 26, 2010, the British Columbia Utilities Commission (Commission) by Letter L-62-10, accepted the FortisBC Energy (then Terasen Gas Inc.) 2010/11 Annual Gas Contracting Plan;
- B. On May 25, 2011 FortisBC Energy filed with the Commission a fully executed copy of a GasEDI Base Contract with amendments called "Standard Provisions of the GasEDI contract for Short Term Sale and Purchase of Natural Gas General Terms and Conditions," negotiated between FEI and Tidal Energy Marketing Inc.;
- C. FortisBC Energy uses the GasEDI Base Contract dated October 26, 2000 for natural gas contracting. The Special Provisions for each gas transaction is confirmed via a deal sheet described in section 9 of the GasEDI Base Contract;
- D. FortisBC Energy has requested that the details of the subject filing be kept confidential for the reasons of commercial sensitivity set out in the filing;
- E. The Commission has reviewed the filing and is satisfied that the Special Provisions to the GasEDI Base Contract for Short Term Sale and Purchase of Natural Gas between FortisBC Energy and Tidal Energy Marketing Inc. is consistent with the Annual Gas Contracting Plan.
