#### ORDER

### WHEREAS:

- A. By Letter L-47-12 dated August 24, 2012, the British Columbia Utilities Commission (Commission) accepted the amended 2012-2013 Annual Gas Contracting Plan (Amended ACP) filed by Pacific Northern Gas Ltd. (PNG);
- B. The Rules for Natural Gas Energy Supply Contracts, Appendix A of Commission Order G-130-06, state that all energy supply contracts for the sale of natural gas to a public utility, other than those for purchases from another public utility, and all subsequent amendments, must be filed with the Commission;
- C. On October 25, 2012, PNG filed with the Commission gas contracts for approval of monthly and daily priced gas supply arrangements (Application);
- D. PNG requests that the details contained in the Application be kept confidential due to its commercially sensitive nature;
- E. The Commission reviewed the Application and is satisfied that the gas supply contracts are appropriate considering market conditions at the time they were negotiated; are in alignment with the Amended ACP; and are in the public interest.
