O R D E R

WHEREAS:

- A. On August 26, 2010, the British Columbia Utilities Commission (Commission), by Letter L-62-10, accepted the FortisBC Energy Inc. (FEI), formerly Terasen Gas Inc., 2010/11 Annual Gas Contracting Plan (ACP);
- B. On January 6, 2011, the Commission by Order E-2-11, accepted FEI's filing of gas supply contracts for the period November 1, 2010 to October 31 2011;
- C. On March 28, 2011, FEI filed with the Commission for acceptance the monthly and daily market premiums for the remainder of the commodity baseload transactions for the period April 1, 2011 to October 31, 2011;
- D. FEI requested that the documents associated with the filing remain confidential due to their commercially sensitive nature as described in the filing's cover letter;
- E. The Commission reviewed the FEI filing and is satisfied that the gas supply contracts are consistent with the ACP and are appropriate considering market prices at the time the contracts were negotiated.
