ORDER

WHEREAS:

- A. On March 30, 2017, pursuant to section 71 of the *Utilities Commission Act* and Section 6.0 of the British Columbia Utilities Commission's (Commission) Rules for Natural Gas Energy Supply Contracts that are set out in Appendix A to Order G-130-06, FortisBC Energy Inc. (FEI) filed for acceptance with the Commission, its Remaining Commodity Baseload Purchases for Summer 2017 (April 2017 October 2017) (Filing);
- B. By Letter L-20-16 dated August 4, 2016, the Commission accepted the FEI the 2016/17 Annual Gas Contracting Plan (ACP);
- C. By Order E-21-16 dated December 7, 2016, the Commission accepted FEI's filling of gas supply contracts for the period of November 1, 2016 to October 31, 2017;
- D. FEI requested that the details of the Filing and associated documents remain confidential for reasons of commercial sensitivity; and
- E. The Commission reviewed the Filing and is satisfied that the commodity supply contract and market factors are appropriate considering the market prices at the time they were negotiated, are consistent with the ACP, and is in the public interest.

NOW THEREFORE pursuant to section 71 of the *Utilities Commission Act* and the British Columbia Utilities Commission's Rules for Natural Gas Energy Supply Contracts, the Commission accepts the natural gas contracts listed in Attachment A to this order. The Commission will keep the details of the FortisBC Energy Inc. March 30, 2017 Filing and associated documents confidential as requested by FortisBC Energy Inc. as they contain commercially sensitive information.
