**O R D E R**

**WHEREAS:**

- A. By Letter L-44-13 dated July 18, 2013, the British Columbia Utilities Commission (Commission) accepted the FortisBC Energy (Vancouver Island) Inc. (FEVI) 2013/14 Annual Contracting Plan (ACP);
- B. On October 31, 2013, FEVI filed with the Commission for acceptance the baseload and seasonal supply allocation between monthly and daily priced contracts as well as the monthly and daily market factors for baseload and seasonal transactions not yet accepted by the Commission;
- C. FEVI requests that the details of the filing be kept confidential for reasons of commercial sensitivity; and
- D. The Commission reviewed the FEVI filing and is satisfied that the supply allocation and the gas supply contract market factors are appropriate considering market conditions at the time they were negotiated, consistent with the ACP, and in the public interest.

**NOW THEREFORE** pursuant to section 71 of the *Utilities Commission Act* and the Commission's Rules for Natural Gas Energy Supply Contracts, the Commission accepts for filing the executed natural gas contracts shown in
