ORDER

WHEREAS:

- A. On July 18, 2013, the British Columbia Utilities Commission (Commission), by Letter L-43-13, accepted the FortisBC Energy Inc. (FEI) 2013/14 Annual Contracting Plan (ACP);
- B. On December 16, 2013, FEI filed for acceptance transportation service agreements FEI executed with Westcoast Energy Inc. (WEI), Nova Gas Transmission Ltd. (NGTL), and Foothills Pipe Lines Ltd. (Foothills) for incremental contracted capacity on the WEI, NGTL and Foothills transmission pipeline systems, respectively, commencing on November 1, 2013 (Agreements), as contemplated in the ACP;
- C. In the December 16, 2013 filing, FEI requested that the Agreements and the filing be kept confidential on the basis they contain commercially sensitive information;
- D. On February 18, 2014, FEI filed a submission noting it wishes to withdraw the request for confidentiality; and
- E. The Commission reviewed the FEI filing and is satisfied that the Agreements are consistent with the ACP and in the public interest.
