## ORDER

## WHEREAS:

- A. By Letter L-43-13 dated July 11, 2013, the British Columbia Utilities Commission (Commission) accepted the FortisBC Energy Inc. (FEI) 2013/14 Annual Contracting Plan (ACP);
- B. On March 26, 2014, FEI applied to the Commission for approval to replace an expiring Aitken Creek Storage agreement with a new 5-year Aitken Creek Gas Storage Agreement (Agreement);
- C. FEI in its filing requests acceptance of the following under section 71 of the *Utilities Commission Act*:
  - The Agreement between FEI and Aitken Creek Gas Storage ULC (ACGS) effective April 1, 2014 to March 31, 2019;
  - The Letter Agreement for Assignment of Spectra Energy T-North Transport between FEI and ACGS for the term April 1, 2014 through March 31, 2015 with renewable rights;
- D. On April 30, 2014, FEI provided additional information relating to the filing;
- E. FEI requests that the filing and associated documents remain confidential due to their commercially sensitive nature; and

F. The Commission reviewed the FEI filing and is satisfied that the Agreement between FEI and ACGS along with the associated T-North Assignment Letter Agreement are consistent with the ACP and in the public interest.

**NOW THEREFORE** pursuant to section 71 of the *Utilities Commission Act* and the British Columbia Utilities Commission's Rules for Natural Gas Energy Supply Contracts, the Commission accepts for filing the executed copy of the Agreement between FortisBC Energy Inc.
