**ORDER TGI-07-2009**

**IN THE MATTER OF THE** *National Energy Board Act* (Act) and the regulations made thereunder;

**AND IN THE MATTER OF** an application by Trans Québec & Maritimes Pipeline Inc. (TQM) for approval of amended interim tolls pursuant to subsection 19(2) and Part IV of the Act filed with the National Energy Board (Board) under File OF-Tolls-Group1-T201-2009-02 01.

**BEFORE** the Board on 24 December 2009.

**WHEREAS** TQM filed an application dated 8 December 2009 seeking approval from the Board of interim tolls effective 1 January 2010;

**AND WHEREAS** TQM has advised the Board that the proposed 2010 interim tolls are set at a level that reflects a continuation of TQM's Board-approved 2009 amended interim revenue requirement;

**AND WHEREAS** the Board has examined TQM's application for 2010 Interim Toll;

**AND WHEREAS** TQM has advised the Board that it provided a draft of its application to its Interested Parties, requesting comments before 7 December 2009;

**AND WHEREAS** TQM has advised the Board that as of 8 December 2009, it received no comments;

**AND WHEREAS** the Board has received no comments;

**THEREFORE, IT IS ORDERED**, pursuant to subsection 19(2) and Part IV of the Act, that:

1. TQM's current interim tolls, which were made effective under Toll Order AO-1-TGI-05-2008, be terminated as of the end of the day on 31 December 2009.

2. TQM's proposed interim tolls, as contained in its application dated 8 December 2009, be implemented effective 1 January 2010 on an interim basis pending a final Order by the Board concerning TQM's 2010 tolls.
