IN THE MATTER OF THE *National Energy Board Act* (Act) and the regulations made thereunder;

AND IN THE MATTER OF an application by Trans Québec & Maritimes Pipeline Inc. (TQM) for approval of amended interim tolls pursuant to subsection 19(2) and Part IV of the Act filed with the National Energy Board (Board) under File OF-Tolls-Group1-T201-2008-01 01.

BEFORE the Board on 30 October 2009.

WHEREAS TQM filed an application dated 9 September 2009, seeking approval from the Board of amended interim tolls effective 1 October 2009;

AND WHEREAS the Board issued a letter dated 15 September 2009 soliciting comments from interested parties;

AND WHEREAS the Board received letters of comment with respect to the application dated 21 September 2009 from the Ministry of Energy and Infrastructure of Ontario, 22 September 2009 from the Industrial Gas Users Association, and 23 September 2009 from the Canadian Association of Petroleum Producers and the Alberta Department of Energy;

AND WHEREAS the Board received a letter from TQM dated 24 September 2009 regarding its service of the Board's 15 September 2009 letter, and reply comments from TQM dated 28 September 2009;

AND WHEREAS the Board issued its decision on the application in a letter dated 29 October 2009 and directed TQM to file revised interim toll schedules to reflect that decision;

AND WHEREAS the Board received TQM's filing dated 29 October 2009 of revised amended interim toll schedules in accordance with the Board's letter decision dated 29 October 2009;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) and Part IV of the Act, that:

1. TQM's current interim tolls, which were made effective under Toll Order TGI-05-2008, be terminated as of the end of the day on 31 October 2009.

2. TQM's interim tolls contained in its schedules filed 29 October 2009, be implemented effective 1 November 2009 on an interim basis pending a final Order by the Board concerning TQM's 2009 tolls.
