ORDER A0-1-TGI-01-2009

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder; and

IN THE MATTER OF an application filed by NOVA Gas Transmission Ltd. (NGTL) with the National Energy Board pursuant to subsections 19(2) and 21(1) and paragraph 60(1)(b) of the Act under file number OF-Tolls-TollsGen-N081-2009-02 01.

BEFORE the Board on 26 June 2009.

WHEREAS the tolls for the Alberta System have been in effect on an interim basis since 29 April 2009 pursuant to Board Order TGI-01-2009 dated 27 April 2009;

AND WHEREAS NGTL filed an application dated 18 June 2009 to amend the 2009 interim tolls contained in NGTL's Alberta System Gas Transportation Tariff;

AND WHEREAS the Board has considered the application and has decided to approve the application as filed;

THEREFORE IT IS ORDERED pursuant to subsections 19(2) and 21(1), and Part IV of the Act, that:

1. the proposed tolls for Pressure/Temperature (PT) Service are approved to be charged on an interim basis effective 1 July 2009;
2. the proposed tolls for Other Service (OS) schedule 2009376113 are approved to be charged on an interim basis effective 1 May 2009;
3. all proposed tolls for OS other than those in schedule 2009376113 are approved to be charged on an interim basis effective 29 April 2009; and
4. the tolls to be charged on an interim basis in accordance with TGI-01-2009 as amended by this Order shall remain in effect until replaced by tolls approved by the Board in a subsequent or amending toll order.
