ORDER TGI-04-2008

IN THE MATTER OF the *National Energy Board Act* (Act) and the Regulations made thereunder; and

IN THE MATTER OF an application filed by Westcoast Energy Inc. carrying on business as Spectra Energy Transmission - West (Westcoast) dated 27 November 2008 pursuant to subsection 19(2) and Part IV of the Act for approval of 2009 Interim Tolls for Transmission in Zones 3 and 4 effective 1 January 2009 under File OF-Tolls-Group1- W102-2008-04 01.

BEFORE the Board on 8 December 2008.

WHEREAS the Board approved an application by Westcoast, dated 27 August 2008 and issued Order TG-03-2008 authorizing the 2008 to 2010 Negotiated Settlement, effective 4 November 2008;

AND WHEREAS Westcoast's application has the unanimous support of its Toll and Tariff Task Force, as evidenced by Toll and Tariff Task Force Resolution 2008-06;

AND WHEREAS the Board has considered Westcoast's application dated 27 November 2008 for 2009 Interim Transmission Tolls for Zones 3 and 4, effective 1 January 2009, and has decided to approve the application as filed;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) and paragraph 60(1)(b) of the Act, that:

- 1. Westcoast shall charge, on an interim basis, effective 1 January 2009, the proposed 2009 Interim Transmission Tolls for Zones 3 and 4 contained in its application dated 27 November 2008, as presented in Resolution 2008-06.
- 2. The interim tolls allowed in accordance with this Order shall remain in effect until they are replaced by a final Order of the Board in a subsequent or amending toll Order.
