ORDER TGI-04-2005

IN THE MATTER OF THE *National Energy Board Act* and the regulations made thereunder;

AND IN THE MATTER OF an application filed with the National Energy Board (the Board) under File ATT-AIT-TQM 10 (4400-T028-10) by Trans Québec & Maritimes Pipeline Inc. (TQM) for certain orders respecting tolls specified in a tariff pursuant to subsection 19(2) and Part IV of the Act.

BEFORE the Board on 21 December 2005.

WHEREAS by application dated 8 December 2005, TQM sought approval from the Board to designate the 2005 Test Year tolls for the transmission of natural gas through its pipeline facilities, made effective through Order TG-05-2005 dated 5 October 2005, as interim tolls effective 1 January 2006.

AND WHEREAS the Board examined TQM's application for 2006 interim tolls;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) of the Act, that the 2005 Test Year tolls, which were made effective under Order TG-05-2005 dated 5 October 2005, be made interim as of 1 January 2006 pending a final order by the Board concerning TQM's 2006 tolls.
