**Trans Québec & Maritimes Pipeline (TQM)
2013 Toll Settlement and 2013 Interim Tolls Application (Application)**

The National Energy Board has received TQM's Application dated 7 December 2012 for approval of its 1 January 2013 to 31 December 2013 Tolls Settlement (the Settlement) as well as for approval of its 2013 Interim Tolls.

Interim Tolls

ORDER TGI-004-2012

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder; and

IN THE MATTER OF an application filed by Trans Québec & Maritimes Pipeline (TQM) with the National Energy Board (Board) pursuant to subsection 19(2) of the *National Board Act Part IV*, filed with the National Energy Board under File OF-Tolls-Group1-T201-2012-02 01

BEFORE the Board on 18 December 2012.

WHEREAS TQM filed an application dated 7 December 2012 (the Application) seeking approval of its 1 January 2013 to 31 December 2013 Tolls Settlement as well as approval of its 2013 Interim Tolls;

AND WHEREAS TQM's 2013 Tolls Settlement is currently before the Board;

AND WHEREAS the proposed 2013 Interim Tolls are determined in accordance with TQM's 2013 Tolls Settlement;

AND WHEREAS TQM solicited comments from interested parties on a draft of the 2013 Tolls Settlement on 26 November 2012 and TQM is not aware of any opposition from Interested Parties to the Settlement or the Application;

AND WHEREAS no person has commented on the Application;

AND WHEREAS the Board has considered the 2013 Interim Toll application and has decided to approve the 2013 Interim Toll application as filed;

THEREFORE, IT IS ORDERED pursuant to subsection 19(2) and Part IV of the Act, that:

1. TQM's current tolls, which were made effective under Order TG-002-2012, are terminated as of the end of the day on 31 December 2012, and
2. TQM's proposed 2013 tolls, as contained in its Application, are implemented effective 1 January 2013 on an interim basis pending any future amending Orders and/or final Order by the Board concerning TQM's tolls.
