ORDER TGI-03-2007

IN THE MATTER OF the *National Energy Board Act* (Act) and the Regulations made thereunder; and

IN THE MATTER OF an application filed by Westcoast Energy Inc. carrying on business as Spectra Energy Transmission - West (Westcoast) dated 30 November 2007 pursuant to subsection 19(2) and Part IV of the Act for approval of 2008 Interim Tolls for Transmission in Zones 3 and 4 effective 1 January 2008 under File OF-Tolls-Group1- W102-2007-02 01.

BEFORE the Board on 18 December 2007.

WHEREAS the Board has considered Westcoast's application dated 30 November 2007 for 2008 Interim Transmission Tolls for Zones 3 and 4 and has decided to approve the application as filed;

AND WHEREAS Westcoast's application has the unanimous support of the TTTF;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) and paragraph 60(1)(b) of the Act, that:

- 1. Westcoast shall charge, on an interim basis, effective 1 January 2008, the proposed 2008 Interim Transmission Tolls for Zones 3 and 4 contained in its application dated 30 November 2007, and presented in Resolution 2007-07.
- 2. The interim tolls allowed in accordance with this Order shall remain in effect until they are replaced by a final Order of the Board in a subsequent or amending toll order.
