Westcoast Energy Inc., carrying on business as Spectra Energy Transmission (Westcoast) - Application for 2011 Interim Tolls for Transmission (Zones 3 and 4)

The Board has examined Westcoast's application dated 23 November 2010 requesting approval of 2011 interim tolls for transmission (Zones 3 and 4), effective 1 January 2011. In its application, Westcoast states that the proposed interim tolls were reviewed with Westcoast's Toll and Tariff Task Force (TTTF) and that the TTTF gave its unanimous support to the tolls, as set out in Issue Resolution 2010-05. The Board has received no comments opposing the application.

ORDER TGI-02-2010

IN THE MATTER OF the *National Energy Board Act* (Act) and the Regulations made thereunder; and

IN THE MATTER OF an application filed by Westcoast Energy Inc., carrying on business as Spectra Energy Transmission (Westcoast) dated 23 November 2010 pursuant to subsection 19(2) and Part IV of the Act for approval of 2011 Interim Tolls for Transmission in Zones 3 and 4 effective 1 January 2011 under File OF-Tolls-Group1-W102-2010-03 01.

BEFORE the Board on 7 December 2010.

WHEREAS on 23 November 2010, Westcoast filed an application for approval of the 2011 interim transmission tolls for transportation service in Zones 3 and 4 (the Application);

AND WHEREAS Westcoast's Toll and Tariff Task Force gave its unanimous support for establishing the 2011 interim tolls at the levels applied-for in the Application, as set out in Issue Resolution 2010-05;

AND WHEREAS the Board has not received any comments opposing the Application;

AND WHEREAS the Board has considered Westcoast's Application, and has decided to approve it as filed;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) and Part IV of the Act, that:

- 1. Westcoast's proposed interim tolls, as contained in the Application, are made interim effective 1 January 2011; and
- 2. The interim tolls approved in accordance with this order shall remain in effect until they are subsequently replaced by amending or final order of the Board.
