ORDER TGI-02-2007

IN THE MATTER OF the *National Energy Board Act* and the regulations made thereunder; and

IN THE MATTER OF an application by Maritimes & Northeast Pipeline (M&NP) dated 7 December 2007 for interim tolls effective 1 January 2008 pursuant to subsection 19(2) and Part IV of the Act filed with the National Energy Board under file OF-Tolls-Group1-M124-2007-02 01.

BEFORE the Board on 13 December 2007.

WHEREAS on 7 December 2007, M&NP applied for approval of interim tolls for services on the M&NP system effective 1 January 2008;

AND WHEREAS the requested interim tolls are set equal to the 2007 final tolls approved by the Board in Order TG-10-2006;

AND WHEREAS the Board has considered M&NP's application and has decided to approve the application as filed;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) and Part IV of the Act that M&NP's tolls are made interim as of 1 January 2008 at a level equal to the tolls in effect pursuant to Order TG-10-2006, pending a final order of the Board concerning 2008 tolls.
