Order TGI-02-2006

IN THE MATTER OF THE *National Energy Board Act* (the Act) and the regulations made thereunder;

AND IN THE MATTER OF an application filed with the National Energy Board (the Board) under File OF-Tolls-Group1-T201-2006-02 01 by Trans Québec & Maritimes Pipeline Inc. (TQM) for certain orders respecting tolls specified in a tariff pursuant to subsection 19(2) and Part IV of the Act.

BEFORE the Board on 7 December 2006.

WHEREAS by application dated 30 November 2006, TQM sought approval from the Board to designate the 2006 Test Year tolls for the transmission of natural gas through its pipeline facilities, made effective through Order TG-09-2006 dated 3 November 2006, as interim tolls effective 1 January 2007;

AND WHEREAS the Board examined TQM's application for 2007 interim tolls;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) of the Act, that the 2006 Test Year tolls, which were made effective under Order TG-09-2006 dated 3 November 2006, be made interim as of 1 January 2007 pending a final Order by the Board concerning TQM's 2007 tolls.
