ORDER TGI-01-2006

IN THE MATTER OF the *National Energy Board Act (Act)* and the Regulations made thereunder; and

IN THE MATTER OF an application filed with the National Energy Board by TransCanada PipeLines Limited (TransCanada) dated 14 November 2006 pursuant to subsection 19(2) and Part IV of the *Act* for approval of Mainline interim tolls effective 1 January 2007 under File OF-Tolls-Group1-T211-2009-09 01.

BEFORE the Board on 24 November 2006.

WHEREAS TransCanada filed an application dated 14 November 2006 for Mainline interim tolls effective 1 January 2007 supported by Unopposed Tolls Task Force Resolution 07.2006;

AND WHEREAS the Board has considered TransCanada's application dated 14 November 2006 and has decided to approve the application as filed;

THEREFORE, IT IS ORDERED, pursuant to subsection 19(2) and Part IV of the *Act*, that:

- 1. TransCanada's current tolls, which were made effective under Toll Order TG-05-2006, be terminated as of the end of the day on 31 December 2006.
- 2. TransCanada's proposed tolls, as contained in its application dated 14 November 2006, be implemented effective 1 January 2007 on an interim basis pending a final Order by the Board concerning TransCanada's 2007 tolls.
