**IN THE MATTER OF THE** *National Energy Board Act* (the Act) and the regulations made thereunder;

**AND IN THE MATTER OF** an application filed with the National Energy Board by Trans Québec & Maritimes Pipeline Inc. (TQM) dated 26 November 2010 for approval of 2010 final tolls pursuant to Part IV of the Act under File OF-Tolls-Group1-T201-2010-03 01.

**BEFORE** the Board on 10 December 2010.

**WHEREAS** the Board approved an application from TQM dated 8 December 2009 and issued Order TGI-07-2009 setting TQM's interim tolls effective 1 January 2010;

WHEREAS TQM filed an application dated 26 November 2010, seeking approval for final 2010 tolls, and submitted further information on 2 December 2010 and 8 December 2010 in response to a Board Information Request;

**AND WHEREAS** the applied-for final tolls are based on the 2010 revenue requirement contained in TQM's 2010-2012 Tolls Settlement;

**AND WHEREAS** Board Order TG-07-2010, dated 19 November 2010, approved TQM's 2010-2012 Tolls Settlement;

**AND WHEREAS** the Board has determined the applied-for tolls are just and reasonable and not unjustly discriminatory;

IT IS ORDERED, pursuant to Part IV the Act, that the tolls are approved as filed.
