Westcoast Energy Inc., carrying on business as Spectra Energy Transmission – West (Westcoast) application for 2007 Final Tolls for Transmission (Zones 3 and 4)

ORDER TG-05-2007

IN THE MATTER OF the *National Energy Board Act* (the *Act*) and the regulations made thereunder; and

IN THE MATTER OF an amended application by Westcoast Energy Inc., carrying on business as Spectra Energy Transmission – West (Westcoast), dated 19 March 2007 pursuant to Part IV and subsection 19(2) of the Act for approval of 2007 final tolls for transmission in Zones 3 and 4 effective 1 January 2007, under file OF-Tolls-Group1-W102-2007-01-01

BEFORE the Board on 26 April 2007.

WHEREAS on 17 August 2006, the Board approved Westcoast's negotiated toll settlement for 2006 and 2007 (Settlement) by Order TG-06-2006 (OF-Tolls-Group1-W102-2005-03-03);

AND WHEREAS on 14 December 2006, Westcoast filed an application for approval of 2007 interim tolls for transmission services in Zones 3 and 4, subsequently approved by the Board on 28 December 2006 by Order TGI-05-2006 (OF-Tolls-Group1-W102-2006-04-01);

AND WHEREAS on 19 March 2007, Westcoast filed an application pursuant to Part IV and subsection 19(2) of the Act for approval of 2007 final tolls to become effective on 1 January 2007;

AND WHEREAS the Board received comments from the Canadian Association of Petroleum Producers on 2 April 2007 in support of the application for 2007 final transmission tolls, and has received no comments or expressions of opposition;

AND WHEREAS the Board has considered Westcoast's 2007 final tolls application dated 19 March 2007 and comments received, and is satisfied that Westcoast's applied-for 2007 final tolls for transmission in Zones 3 and 4 as set out in the application are just and reasonable;

IT IS ORDERED pursuant to Part IV and subsection 19(2) of the Act, that:

- 1. Westcoast shall charge 2007 transmission tolls for Zones 3 and 4 as set out in the application;
- 2. The application is approved as filed;
- 3. Order TGI-05-2006, which authorized tolls that Westcoast may charge on an interim basis effective 1 January 2007, is revoked and the tolls that had been authorized thereunder are hereby disallowed; and
- 4. Westcoast is directed to refund or recover that part of 2007 interim tolls charged under Order TGI-05-2006 by Westcoast from 1 January 2007 to when 2007 final tolls approved by this Order are effective, that is either greater or less than the tolls determined by the Board to be just and reasonable in this Order, together with carrying charges on the amounts so refunded or recovered calculated in accordance with the Settlement.
