ORDER TG-005-2012

IN THE MATTER OF THE *National Energy Board Act* (the Act) and the regulations made thereunder; and

AND IN THE MATTER OF an application filed with the National Energy Board by Foothills Pipe Lines Ltd. (Foothills) dated 31 October 2012 for approval of 2012 Final Tolls pursuant to Part IV of the Act under File OF-Tolls-Group1-F115-2012-01 01.

BEFORE the Board on 12 December 2012.

WHEREAS Board Order TGI-005-2011, issued 9 December 2011, approved Foothills' interim tolls for Foothills Zones 6, 7, 8 and 9 to be effective 1 January 2012;

AND WHEREAS Foothills filed an application dated 31 October 2012 seeking approval for 2012 final tolls (the Application);

AND WHEREAS the applied-for final tolls are based on the methodology approved by the Board in Decision TG-8-2004 as amended by order TG-03-2007;

AND WHEREAS Foothills presented its shippers and interested parties with its proposal for 2012 final tolls and sent a copy of the Application to its shippers on 31 October 2012;

AND WHEREAS no person has commented on the Application;

AND WHEREAS the Board has determined that the applied-for tolls are just and reasonable;

AND WHEREAS the Board has considered the Application and has decided to approve the Application as filed;

THEREFORE IT IS ORDERED, pursuant to Part IV of the Act, that:

1. Interim tolls authorized in Order TGI-005-2011 and charged from 1 January 2012 are hereby made final for the period ending 31 December 2012.
