TransCanada PipeLines Limited (TransCanada) New Delivery Point on Mainline System

On 22 February 2006, TransCanada filed an application with the National Energy Board requesting approval to add the Bécancour delivery point to the GMi Eastern Delivery Area. On 23 February 2006, TransCanada filed an amended application with the Board to change the name of the new delivery point to Champlain.

By letter dated 3 March 2006, the Board sought comments on TransCanada's application. Given that no party filed a letter of comment opposing the application, TransCanada, in a letter dated 7 March 2006, recommended that the Board approve the application as filed.



ORDER TG-04-2006

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder; and

IN THE MATTER OF an application by TransCanada PipeLines Limited (TransCanada) dated 22 February 2006, pursuant to part IV of the Act, for approval to add the new delivery point Champlain to the GMi Eastern Delivery Area, filed with the National Energy Board under File –TT-TC-TCP-29 (4775-T001-1-29).

BEFORE the Board on 10 March 2006.

WHEREAS TransCanada filed an application dated 22 February 2006 with the Board requesting approval to add the new delivery point Bécancour to the GMi Eastern Delivery Area effective 1 April 2006;

AND WHEREAS on 23 February 2006, TransCanada filed an amended application with the Board to change the name of the new delivery point from Bécancour to Champlain;

AND WHEREAS on 3 March 2006, the Board sought comments from shippers, Tolls and Task Force members and interested parties;

AND WHEREAS no parties submitted comments;

AND WHEREAS the Board has considered TransCanada's application;

IT IS ORDERED THAT, pursuant to Part IV of the NEB Act, effective 1 April 2006, Champlain is designated as a delivery point in the GMi Eastern Delivery Area on TransCanada's Mainline.
