**ORDER TG-003-2012**

**IN THE MATTER OF THE** *National Energy Board Act* (the Act) and the regulations made thereunder; and

**AND IN THE MATTER OF** an application filed with the National Energy Board by Trans Québec & Maritimes Pipeline Inc. (TQM) dated 22 June 2012 for approval of 2012 Final Tolls pursuant to Part IV of the Act under File OF-Tolls-Group1-T201-2012-01 01.

**BEFORE** the Board on 9 August 2012.

**WHEREAS** Board Order TG-07-2010, dated 22 November 2010, approved TQM's 2010-2012 Tolls Settlement;

**AND WHEREAS** the Board approved an application from TQM dated 1 December 2011 and issued Order TGI-006-2011 setting TQM's 2012 interim tolls effective as of 1 January 2012;

**AND WHEREAS** TQM filed an application dated 22 June 2012, seeking approval for 2012 Final Tolls;

**AND WHEREAS** the applied-for final tolls are based on a 2012 revenue requirement calculated in accordance with TQM's 2010-2012 Tolls Settlement;

**AND WHEREAS** no party has responded to the Board's 12 July 2012 letter inviting comments on TQM's 2012 Final Tolls;

**AND WHEREAS** the Board has determined the applied-for tolls are just and reasonable and not unjustly discriminatory;

**IT IS ORDERED**, pursuant to Part IV of the Act, that:

1. Order TGI-006-2011, which authorized tolls that TQM may charge on an interim basis effective 1 January 2012, is revoked;
2. TQM's applied-for final tolls, as contained in its application dated 22 June 2012 are approved as final, effective 1 January 2012.

3. TQM is directed to refund toll payers the difference between the 2012 interim tolls authorized by Order TGI-006-2011 and the 2012 final tolls authorized by this Order.
