ORDER TG-02-2010

IN THE MATTER OF the *National Energy Board Act* (Act) and the Regulations made thereunder; and

IN THE MATTER OF an application for approval of 2010 Final Tolls for Transmission in Zones 3 and 4, dated 14 June 2010, filed by Westcoast Energy Inc., carrying on business as Spectra Energy Transmission (Westcoast) pursuant to Part IV of the Act, under File OF-Tolls-Group1-W102-2010-01 01.

BEFORE the Board on 23 June 2010.

WHEREAS the Board approved an application by Westcoast, dated 27 August 2008, and issued Order TG-03-2008 authorizing the 2008 to 2010 Negotiated Settlement (Settlement), effective 4 November 2008;

AND WHEREAS on 27 November 2009, Westcoast filed an application for approval of 2010 interim tolls for transmission service in Zones 3 and 4, subsequently approved by the Board on 9 December 2009 by Order TGI-03-2009;

AND WHEREAS on 14 June 2010, Westcoast filed an application pursuant to Part IV of the Act for approval of 2010 final tolls;

AND WHEREAS the applied-for 2010 final transmission tolls were reviewed and unanimously approved by Westcoast's Toll and Tariff Task Force (TTTF) Issue Resolution Sheet 2010-02:

AND WHEREAS the Board received comments from the Canadian Association of Petroleum Producers on 16 June 2010 in support of the application;

AND WHEREAS the Board has considered Westcoast's application dated 14 June 2010 for 2010 Final Transmission Tolls for Zones 3 and 4 and, having found the tolls to be just and reasonable, has decided to approve the application as filed;

THEREFORE, IT IS ORDERED, pursuant to Part IV of the Act, that:

- 1. Westcoast's 2010 interim tolls for Zones 3 and 4, which were made effective under Toll Order TGI-03-2009, are hereby made final for 1 January 2010 to 30 June 2010; and
- 2. Westcoast's proposed tolls, as contained in its application dated 14 June 2010, are approved as final effective 1 July 2010 to 31 December 2010.
