**ORDER TG-01-2010**

**IN THE MATTER OF THE** *National Energy Board Act* (Act) and the regulations made thereunder;

**AND IN THE MATTER OF** an application filed with the National Energy Board (Board) under File OF-Tolls-Group1-T201-2010-01 01 by Trans Québec & Maritimes Pipeline Inc. (TQM) dated 6 May 2010 for approval of 2009 final tolls pursuant to Part IV of the *Act*.

**BEFORE** the Board on 22 June 2010.

**WHEREAS** the Board issued a letter dated 4 September 2008 approving an application by TQM for a Partial Settlement of its 2007 to 2009 revenue requirement;

**AND WHEREAS** the Board issued Order TGI-05-2008 approving 2009 interim tolls effective 1 January 2009;

**AND WHEREAS** the Board issued amending Order AO-01-TGI-05-2008 approving 2009 interim tolls effective 1 November 2009 to 31 December 2009;

**AND WHEREAS** TQM filed an application dated 6 May 2010 seeking approval from the Board to set 2009 final tolls at the levels previously approved as interim;

**AND WHEREAS** no party has submitted any comment in objection to the application;

**AND WHEREAS** the Board finds that the applied-for final TQM tolls for 2009 are just and reasonable;

**THEREFORE, IT IS ORDERED**, pursuant to Part IV of the Act, that the applied-for tolls in TQM's 6 May 2009 application are approved as filed and are to be implemented as final TQM tolls for 2009.
