**TransCanada PipeLines Limited (TransCanada)  
Application for Approval of Short Notice Balancing (SNB) Toll Methodology and  
Interim SNB Toll for the Eastern Zone**

On 25 January 2008, TransCanada filed an application with the Board for approval, pursuant to Part IV of the *National Energy Board Act*, of a toll methodology for SNB and to amend Order TGI-01-2007, to include the proposed interim SNB toll for the Eastern Zone. The application is supported by unopposed TTF Resolution 01.2008.

The Board has examined TransCanada's application and has decided to approve the application as filed. Please find enclosed a copy of Order AO-01-TGI-01-2007 which gives effect to this decision. The Board reminds TransCanada that, as stated in the RH-1-2006 Reasons for Decision, it expects TransCanada to file with the Board, two years after natural gas starts to flow under a Firm Transportation Short Notice (FT-SN) contract, a report on the use of FT-SN and SNB services.

TransCanada is directed to serve a copy of this letter and the enclosed Order on its TTF Members, Mainline shippers and RH-1-2006 interested parties.

**ORDER AO-01-TGI-01-2007**

**IN THE MATTER OF** the *National Energy Board Act (Act)* and the regulations made thereunder; and

**IN THE MATTER OF** an application filed with the National Energy Board by TransCanada PipeLines Limited (TransCanada) dated 25 January 2008 pursuant to Part IV of the *Act* for approval of an interim Short Notice Balancing (SNB) toll for the Eastern Zone effective 1 January 2008 under File OF-Tolls-Group1-T211-2008-01 01.

**BEFORE** the Board on 12 February 2008.

**WHEREAS** TransCanada filed an application dated 16 November 2007 for Mainline interim tolls effective 1 January 2008 supported by unopposed Tolls Task Force (TTF) Resolution 13.2007;

**AND WHEREAS** the Board has approved the application for Mainline interim tolls as filed and issued Order TGI-01-2007;

**AND WHEREAS** TransCanada filed an application dated 25 January 2008, requesting approval for a toll methodology for Short Notice Balancing (SNB) services and a proposed interim SNB toll of \$3.07144 GJ/month for the Eastern Zone effective 1 January 2008 and supported by unopposed TTF Resolution 01.2008;

**AND WHEREAS** the Board has considered TransCanada's 25 January 2008 application and has decided to approve it as filed;

**THEREFORE, IT IS ORDERED**, pursuant to subsection 19(2), 21(1) and Part IV of the *Act*, that TransCanada's current Mainline interim tolls, which were made effective under Toll Order TGI-01-2007, be varied to include an interim SNB toll of \$3.07144 GJ/month for the Eastern Zone effective 1 January 2008.
