**TransCanada PipeLines Limited (TransCanada) – Application for Amendment to Interim Tolls to correct the Enbridge EDA STS toll effective 1 January 2009**

**ORDER AO-01-TGI-03-2008**

**IN THE MATTER OF** the *National Energy Board Act* (NEB Act) and the Regulations made thereunder; and

**IN THE MATTER OF** an application filed with the National Energy Board by TransCanada PipeLines Limited (TransCanada) dated 5 February 2009 pursuant to subsection 19(2) and Part IV of the NEB Act for approval of an order amending Interim Tolls to correct the Enbridge EDA STS toll effective 1 January 2009 under file OF-Tolls-Group1-T211-2008-06 02.

**BEFORE** the Board on 20 February 2009.

**WHEREAS** TransCanada filed an application dated 25 November 2008 for Mainline interim tolls effective 1 January 2009 in accordance with Tolls Task Force (TTF) Resolution 08.2008;

**AND WHEREAS** the Board approved TransCanada's 25 November 2008 application, and issued Order TGI-03-2008 on 5 December 2008 for Mainline interim tolls effective 1 January 2009;

**AND WHEREAS** TransCanada filed an amendment dated 16 December 2008 correcting typographical errors in the List of interim tolls, effective 18 December 2008;

**AND WHEREAS** TransCanada filed an application dated 5 February 2009 proposing to correct an error in the Enbridge EDA STS toll, effective 1 January 2009;

**AND WHEREAS** the Board has considered TransCanada's application dated 5 February 2009 and has decided to approve the application as filed;

**THEREFORE, IT IS ORDERED**, pursuant to subsection 19(2) and Part IV of the NEB Act, that:

1. TransCanada's current interim Enbridge EDA STS toll, which was approved under Toll Order TGI-03-2008, be terminated effective 1 January 2009;
2. TransCanada's proposed Enbridge EDA STS toll, as contained in its application dated 5 February 2009, be implemented effective 1 January 2009 on an interim basis pending a final order by the Board concerning TransCanada's 2009 Mainline tolls; and

3. The difference between the interim Enbridge EDA STS toll approved under Toll Order TGI-03-2008 and this Toll Order AO-01-TGI-03-2008 shall be credited back to the Shipper.
